1148 / In the first half of 2014, IOM in Slovakia helped 23 migrants to return from Slovakia to 13 home countries and provided comprehensive assistance to 12 Slovak citizens who became victims of trafficking in human beings abroad. IOM Migration Information Centre in Bratislava and Kosice counselled 1,113 clients.

649 / Already 649 refugees from Africa and Asia found a temporary shelter in the Emergency Transit Centre (ETC) in Humenne between August 2009 and June 2014. IOM, in cooperation with its partners, organizes their <u>humanitarian transfer</u> through Slovakia, where they complete the needed preparations, and then arranges their transportation to countries providing them with a new home.

349 / During the first six months of 2014, 349 people attended <u>the</u> open courses of Slovak language organized by IOM Migration Information Centre (MIC) for non-EU citizens living in Slovakia.

IOM Has Trained More Than 440 Professionals



In April IOM Bratislava organized two workshops in Trenčín and Dunajská Streda for officers from alien police departments and officials from labour and district offices, insurance company Union and labour inspectorate. The participants gained infor-

mation on the latest legislative changes (Act on Residence of Foreign Nationals and Act on Employment Services), presented the activities and services of their institutions in the field of migration and solved case studies that can be helpful in their future work and communication with third-country nationals.

Since the beginning of this capacity building project for public sector and local government workers in 2010, IOM has organized 20 initial trainings and 12 follow-up workshops in seven regions of Slovakia. More than 440 professionals from key institutions all over Slovakia attended these events. <u>More information</u>.

The visitors could get to know the culture and customs of different countries and also taste food specialities from Brazil, Iran, Ghana, Latin America and Kazakhstan. Among other organizations, the International Organization for Migration (IOM) presented both itself and the activities and services of the <u>IOM Migration Information Centre (MIC)</u>. Next Door Family film at the [fjúžn] Festival



Zuzana Vatráľová from the International Organization for Migration (IOM), Miroslava Hlinčíková from the Institute for Public Affairs and the Institute of Ethnology of the Slovak Academy of Sciences and Aaron Chase from the toy store Hravý svet met at the [fjúžn] festival in the discussion *What Kind of Neighbours Are We?* The audience learnt interesting things about research on the integration of migrants at local level and about migrants' experience with violence, and personal experience with life of foreigner in Slovakia. The discussion opened with the film <u>Next Door Family</u> documenting the coexistence of the majority communities and migrants in Slovakia and five other European countries. <u>Read more</u>.

Another 33 Refugees Are Preparing for Life in a New Country



In May 2014, a new group of 33 Ethiopian and Somali women and families with children arrived to Slovakia, where they were provided with a temporary shelter. The women and families with children had to leave their homes and they fled to Yemen. The refugees' return to their home countries is not possible; due to the trauma they had survived and risk of persecution, they were granted international protection and included in the program of humanitarian transfer of refugees. IOM organized their transportation from refugee camp to Slovakia. For a period of 6 months they will be accommodated in the Emergency Transit Centre (ETC) in Humenne. The Centre is an important part of the refugees' journey towards a new life. Here they will undergo medical examinations and complete other necessary preparations. After that IOM will arrange the refugees' transportation to the countries that will provide them with a safe home.

Courses of cultural orientation are part of the preparations refugees need to complete before resettlement. With the IOM staff they get to know the culture and customs of the country they will be resettled to, and so prepare as much as possible for their new lives already during their stay in Slovakia. Refugees receive information on social and health system of the receiving country; on how to look for a job or enroll in school; or on the currency of their new home and on how to plan their household monthly budget.

Trained Social Workers Are Helping Their Communities

In May 2014 IOM organized education sessions for 24 field social workers in the **prevention of trafficking in human beings** (THB). During the two-day workshop "Training of Trainers" lecturers from IOM introduced current trends in THB and their experience with the assistance to Slovak citizens who became victims of this crime. These victims come mainly from Eastern Slovakia, which is also where the workshop participants work. An important part of the workshop was a training of preventive activities that the workers can use in their work with communities and in passing information and skills in the field of prevention of THB to their colleagues.

The World in Your Palms

Migrants from 10 Countries at IOM One-Stop Shops in June

Migrants from more than 10 countries benefited from the services of One-Stop Shops – advisory days for migrants from outside the European Union, which were organized by MIC on June 26, 2014 simultaneously in Bratislava and Kosice. On the One-Stop Shops migrants received important information from various aspects of life and stay in Slovakia from representatives of the alien police department, experts from the labour office, health insurance company and consultants of the MIC.

She Went Abroad to Help Her Family



Ms. Vu Thi My left her native Vietnam and departed for Russia to help her sister. Ms. My lived with her son for some time in Moscow where she worked in a garment factory. "I did not have enough money and experience to open my own business," she said. Life in

Russia was difficult for her, because she had to pay high school fees for her son, but was receiving only a low salary at the factory.

"My cousin called me to come to her to Slovakia," she remembers. "She promised to pay a higher salary to me, but on arrival I found out that she had lied." She crossed the Slovak border illegally. "I did not have proper documents and I was without any help from my family," she remarks. "I really regretted my decision..." You can watch My's entire story in the <u>documentary film</u>.

Annual Report on Migration and Asylum Policies in the Slovak Republic 2013

The report provides information about the most significant political and legislative developments, as well as public debates in the field of migration and asylum in Slovakia during the year 2013. It focuses on legal migration and mobility, irregular migration and return, interna-

tional protection and vulnerable groups. Apart from this, the report also analyses measures against trafficking in human beings, migration and development policy as well as implementation of EU legislation. The annual report is available for download in <u>Slovak</u> as well as in <u>English</u>.

Detention and Alternatives to Detention in the Context of the Migration Policy of the Slovak Republic

English version (available as a questionnaire) deals with legislative regulation and good practice in the field of detention and alternatives to detention of third-country nationals, while discussing the reasons for detention and release from detention. It provides mapping of



the types of detention facilities as well as conditions in detention. The impact of detention and alternatives to detention is analysed in relation to returns and international protection procedures.
