During the first three months of 2014 the [IOM Migration Information Centre \(MIC\)](#) provided 863 consultations to 576 clients from more than 70 countries.

From January to March 2014, 80 employees from state and public institutions participated in IOM trainings and workshops about migration, intercultural skills and regional cooperation. These events help the participants in their work with migrants in Slovakia.

From October 2012 to April 2014, IOM helped 124 Slovak citizens who were not granted asylum in Canada. IOM provides them with assistance before and during their return from Canada and reintegration assistance in Slovakia.

## PREVIOUS ACTIVITIES

### 114 New Refugees Found a Temporary Shelter in Slovakia



Between January and March 2014 the Slovak Republic provided a temporary shelter on its territory to 114 new refugees. The refugees come from Afghanistan and Somalia, and they will stay in Slovakia for a period of 6 months. They were forced to leave their home countries due to war and unrest. Resettlement to a third country is for them an only chance for life in dignified and safe conditions. Their stay in Slovakia will enable them to complete the preparations needed for their successful resettlement.

During their stay in Slovakia, the families and women with children will be accommodated in the Emergency Transit Centre (ETC) in Humenne, which is located in the asylum facility of the Slovak Ministry of Interior. [IOM is responsible](#) for the transportation of refugees from a refugee camp to the Slovak Republic and from the Slovak Republic to a country of resettlement. It also provides services related to medical examinations and cultural orientation which prepares the refugees for life in new country.

## IOM Trained Representatives of State and Public Administration



In the first quarter of 2014, IOM Bratislava organized [two trainings and four follow-up workshops](#) for experts from state and public administration working with third-country nationals. These events are part of a capacity building project aimed at fostering intercultural communication skills, increasing knowledge in the field of migration and migrant integration, providing information on the latest legislative changes (Act on Residence of Foreign Nationals and Act on Employment Services) and supporting regional cooperation of relevant institutions.


The workshops took place in Banská Bystrica, Žilina, Košice and Prešov. Three of them included counselling days for migrants. Around 30 migrants or their representatives from more than 10 non-EU countries used the opportunity to get free information on residence, employment, citizenship or starting a business in Slovakia.

## IOM Supports Migrant Communities

[Representatives of migrant communities in Slovakia](#), in cooperation with the IOM Migration Information Centre (MIC), organized several events in the first three months of 2014:

**Goodbye Winter, Hello Spring.** Indian, Peruvian and Russian community in Košice organized a happening to introduce various festivities welcoming the spring season – Slovak *Fašiangy*, Russian *Maslenica*, Indian *Holi Festival* or Peruvian carnival. Visitors learned about the customs and traditions associated with these celebrations, tasted traditional dishes of different cultures and danced to the rhythm of Latin American music.

**Babinec.** Islamic Foundation organized its traditionally popular *Babinec* dedicated to women of all continents. The rich three-day program was full of colours, workshops, education, emotions and smell of Moroccan tea. Theatrical performance *Painted With Fear* was part of *Babinec*, followed by a discussion with its cast.



**Ecuadorian Film Festival.** A small Ecuadorian community organized a first film festival held in Nitra and Bratislava. Six movies of Ecuadorian production were screened during four weeks, offering a view of the country's identity through their impressive stories.



**Francophone Africa.** Lovers of the French language had the unique opportunity to attend an information meeting *Francophone Africa*, held on the International Day of Francophony in March. Migrants from the four countries of Francophone Africa discussed how the French language influenced culture, history and the relationship of their country to the current migration trends.



**Persian World Celebrated their New Year – Nawroz 1393.** In Slovakia, members of the Afghan and Iranian communities were joined in celebration by people from the countries of Central Asia and by their Slovak and international friends. The arrival of the New Year was celebrated with singing and dancing. Haft – a traditional table with symbols of *Nawroz* and the upcoming spring was also prepared.

## Migrants Seek Counselling at One-Stop Shops



The IOM Migration Information Centre (MIC) organized specialized counselling days for migrants again. The so-called *One-Stop Shops* were held on 6 February 2014 in Košice and 27 March 2014 in Bratislava. Migrants from more than 15 countries visited them and obtained counselling at one place from the representatives of the alien police department, labour office, health insurance companies and MIC consultants.

### Do You Find Working in Britain for £ 20 a Week Attractive?

Marek from eastern Slovakia found himself in financial troubles. To solve them, he was looking for a job but with no success. In summer 2013, he was approached by Laco – his acquaintance who had already been living in England for a long time and came to Slovakia just for holidays. He offered Marek an opportunity to earn some money in Bradford working as a construction worker. Marek was told that he could live at Laco's place and did not have to arrange anything apart from getting to the place. Marek liked the offer so he left Slovakia.

After the arrival, everything looked very promising. The accommodation was not ideal as there was no hot water, but Laco promised that it was just temporary. Marek did not sign any employment contract, he just handed in his documents and immediately began working as a bricklayer on a private site belonging to a man from Pakistan. However, after a few days this man got quite aggressive, he even hit Marek several times. He forced Marek to work from early morning until late night. Marek slept too little and had to work even when sick. He was paid 20 pounds a week, but he had to hand the money to Laco as an installment for the rent and modest food. Marek was trying to stand up for his rights and wanted to leave several times. Laco did not seem to object. However, he never forgot to remind Marek that without him and his money, he would be left on the street where anything could happen to him. Laco also warned Marek that if got caught by the English police, he would go straight to prison.

Marek successfully escaped in late autumn and was living in street in Bradford. While living there he was beaten up by a group of strangers so badly that he ended up in hospital with broken ankles. At the end of December, social workers from CRI Reconnections learnt about him and offered him help. Marek was still afraid to cooperate with the police and he would have

no place to live after being discharged from hospital. Therefore CRI Reconnections assisted him with obtaining his documents and buying a plane ticket. They also asked IOM Bratislava to urgently help this a client who was in a very vulnerable situation. Marek arrived in Slovakia on 31 December 2013, he spent the New Years' Eve in safe accommodation and was able to join his family after New Year.

### Minh from Vietnam: Without IOM Support I Could Not Have Returned Home



Mr. Minh left Vietnam in 2008 and he came legally to work in Slovakia. He was employed as a factory worker. In order to get this job, he ran up debts and when the factory closed down due to the crisis, he found himself in a hopeless situation and without any money for returning home. „When my residence permit became invalid, I earned some little money working as a construction worker or as a waiter in restaurant, but I did not feel good,” he says. He could not work, travel or go shopping without the fear of being arrested. The situation was getting worse because he was separated from his family. „When I emigrated, my son was too young and every day he called me to ask when I would come back home,” he says. At that point he had to decide what to do next...


### Counselling on Changes in the Act of Residence for Foreigners

From 1 January 2014, an amendment of the Act No. 404/2011 Coll. on Residence of Foreign Nationals and Act 5/2004 Coll. on Employment Services came into effect. The changes relate to the terms of residence, work permit, or employment of foreign nationals in Slovakia.


#### Residence of Foreigners in Slovakia


